The following are the estimated costs for attending one academic year at Valley City State University. A number of the cost items, including board, personal/miscellaneous, and books and supplies, are estimates and can be substantially less than what is indicated here.

\*Tuition, fees, books and supplies estimated above are for the academic year (two semesters—Fall and Spring) and assume the student is enrolled in 15 credits per term. Tuition and fees per credit charge is about \$568.58..

\*\*This estimate assumes a double occupancy dorm room for the student living on campus. For the student living off campus, this estimate assumes the student is sharing the cost of living accommodations with another student.

\*\*\*The North Dakota University System requires all international students (excluding students from Canada) to have health insurance. The insurance charge is based on a full academic year and is charged once per year.

\*\*\*\*Personal/miscellaneous estimate includes housing and meals during vacation periods as well as clothing, transportation and incidental expenses. Married students should add at least \$2500 for each additional dependent.
