The total investment figure indicated below is what will be indicated as a total cost on the I-20, the form required for entry into the United States for university study. These costs will vary depending on the number of credits you take in a year's time, as well as other factors, such as board plan level chosen and personal needs throughout an academic year. Tuition is based on 15 credits per term.

* Tuition, fees, books and supplies estimated above are for the academic year (two semesters – Fall and Spring). Per credit charge is \$190.00.

** This estimate assumes a double occupancy dorm room for the student living on campus. For the student living off campus, this estimate assumes the student is sharing the cost of living accommodations with another student.

Four meal plans are available at Valley City State University. This estimate is based on the most popular meal plan; plan number three. If the student chooses plan one or two it will be less. If meal plan four is chosen, it will be more.

***Personal/Miscellaneous estimate includes housing and meals during vacation periods as well as clothing, local transportation and incidental expenses. Students with dependents should add at least \$2500 for each dependent.
